JODI Participation Assessments

Why do we have JODI Participation Assessments?

• To measure the degree of participation in the initiative by each economy.

How often do we do this Assessments? And what is the criteria of the Assessments?

- The bi-annual assessment considers three measures: sustainability, timeliness and completeness.
- Smiley Faces
 - 🙂 Good
 - 🙂 Fair
 - ⊗ Less Reliable

Sustainability

- © if the **6 questionnaires** have been submitted;
- if 4 or 5 questionnaires have been submitted;
- 😕 when less than 4 questionnaires have been submitted

Timeliness

- when all 6 submissions during the assessment period have been submitted within two months of the end of the reference month relevant to each submission;
- (a) when 4 or 5 submissions have been received on time;
- 🙁 when less than 4 submissions have been received on time

Completeness

- when more than 90% of the data are given for production, stock change/closing and demand, etc.;
- ☺ when between 60% and 90% of the data are given;
- ${\ensuremath{ \ensuremath{ \otimes } }}$ when less than 60% of the data are given







- We have successfully received reports by whole economies (13/13) from Jan to Jun and Aug 2022
- 6 out of 13 Non-OECD member economies were able to submit on the set deadline





- **8 out of 13** Non-OECD member economies were able to submit on the set deadline •
- We are trying to acquire the JODI Gas data from **2** member economies (**PNG** and **Peru**)

 From Jan 2021 to Dec 2022, 3 member economies (Hong Kong, China; Singapore and Chinese Taipei) have perfect 24 within M-1

• 8 member economies reported all months' data within M-2

Completeness (JODI Oil)

Products and Flows are not reported (based on the latest submission)

Conclusions

Sustainability:

- In 2022, 12 out of 13 non-OECD member economies were able to submit their JODI Oil data, other than PNG. And 11 out of 13 non-OECD economies were able to submit their JODI Gas data, other than PE and PNG.
- For VN, ESTO finally have received JODI Oil/Gas reports from Jan to Aug 2022.

<u>Timeliness:</u>

About <u>45%</u> (JODI Oil)/ <u>60%</u> (JODI Gas) of economies submitted within M-1 up to Dec 2022;

<u>Completeness:</u>

- 8 (BD; HKC; INA; PNG; PER; PHL; CT and THA) of non-OECD member economies reported more than <u>90%</u> of JODI Oil data;
- 6 (BD; HKC; INA; PHL; CT and THA) of non-OECD member economies reported more than <u>90 %</u> of JODI Gas data.
